# Team Types & Information

#### b. U.S. Domestic Teams

- eXp Realty provides legally married couples in the U.S. the option of a Domestic Team structure. It includes:
- ICON eligibility with one award to the team
- One capped transaction fee of \$5,000
- One Risk Management fee of \$40 per transaction, capped at \$500 per year
- One shared commission cap of \$16,000
- One join fee of \$149
- Reduced monthly fee of \$50 for secondary member

# **Commission, Cap, Fees**

#### **Commission & Cap**

80/20 commission split \$16,000 cap

After that earn 100% commission for the remainder of anniversary year  $^{\rm 1}$

#### Standard Costs<sup>2</sup>

- \$149 start-up fee
